On The Hill

July was an action-packed month on the Hill as Congress worked hard to wrap up several high priority agenda items ahead of the August recess. With negotiations stalling on the Bipartisan Innovation Act, Congress was urged by the national security community to act with urgency to pass the CHIPS Act portion of the bill (which funds domestic semiconductor manufacturing) as a standalone. Congress worked quickly to pass a package which included the CHIPS Act as well as several other research and development and education provisions from the broader USICA/COMPETES Act negotiations that had bipartisan support.

Congress continues to move through the 2023 budget cycle, with the House passing their suite of appropriations bills in July. The House-passed bills had particularly significant increases to the budget for the Department of Education. The Senate released their draft bill text last week, giving us a fuller picture of the differences and similarities between the two chambers. The Senate is expected to move forward with these bills after the August recess. Given the fiscal year is set to end on September 30, our team has been told that they will first pass a continuing resolution which will push a final vote on the 2023 budget to after the November election.

Another big announcement that came in this month confirmed what we had already been told: Senator Manchin and Senator Schumer had been negotiating for several months on an updated budget reconciliation package similar to last year's unpassed Build Back Better Act. The two came to an agreement on a slimmer package that includes support for certain Medicaid reforms, tax changes, and climate provisions. If the package can win support from all 50 Democrats (including Senator Sinema of Arizona, a key swing vote), we expect this to move quickly, with the House potentially returning during August to vote on the updated bill.

Bipartisan Innovation Act

With the Bipartisan Innovation Act Conference Committee making little progress on a final agreement, Congressional leadership moved to pass a smaller, but still nearly 1000-page, bill which included provisions with broad support. The new "CHIPS-Plus" package includes many similar provisions to the original House-passed America COMPETES Act and Senate-passed US Innovation and Competition Act, minus trade and climate initiatives.

Division A of the bill appropriates over \$52 billion over five years in incentives to develop semiconductor manufacturing capacity in the United States.

The largest section, Division B, is rooted in the science titles of the America COMPETES Act and USICA. However, those bills had two different approaches to boosting and re-prioritizing federal support for scientific research and development. The final package pulls from both approaches and authorizes over \$100 billion in additional science funding at NSF, the National Institute of Standards and Technology (NIST) and the Department of Commerce.

In particular, the Act establishes a new NSF Directorate for Technology, Innovation and Partnerships, whose mission is "to advance research and development, technology deployment, and related solutions to address United States societal, national, and geostrategic challenges, for the benefit all Americans." The bill authorizes \$20 billion over five years for the new Directorate. The directorate will focus on key technologies, including artificial intelligence, quantum, and synthetic biology, among others. Support for fellowships and scholarships and enhancing research capacity for HBCUs and MSIs is also addressed.

\$10 billion is authorized for the development of at least 20 regional technology and innovation hub programs to support domestic leadership in sectors critical to national and economic security. The goal is to promote regional economic development and resilience (especially within rural and underserved communities), expand advanced domestic manufacturing, and address the intersection of emerging technologies and regional or national challenges. Of the 20 hubs established, one-third must significantly benefit small and rural communities, and one third must benefit states or territories benefiting from the Established Program to Stimulate Competitive Research (ESPCoR) of the NSF.

The bill authorizes new and existing research initiatives through the Department of Energy relating to basic energy science, biological and environmental research, advance scientific computing research, fusion energy research, high energy physics and nuclear physics. Within the education space, the Department of Energy Research and Innovation Act is amended to now authorize programs that foster collaboration between teachers at elementary schools and secondary schools, students and faculty at institutions of higher education, early-career researchers, and the National Laboratories.

Within NSF, NTIA, and NASA, the bill authorizes \$13 billion for scholarships, fellowships, and traineeships to foster STEM education and create workers in critical fields, including to establishing an artificial intelligence scholarship-for-service program, a national network for microelectronics education, and cybersecurity workforce development programs.

Expansion of rural STEM education is also included in the package. The bill provides for research and development to increase access to STEM education opportunities in rural K-12 schools and to provide teachers with the resources they need to teach more effectively.

Some House Republicans withdrew their support on the eve of the final vote after Senate Democrats unveiled plans to quickly pass an unrelated partisan reconciliation bill, but regardless of this, the CHIPS-Plus package passed with bipartisan support in July. The President is set to sign the bill into law in the coming days.

COTA Act

This month, the COTA Act gained one additional cosponsor, Rep. Susie Lee (D-NV). While there is not yet a clear path forward for the bill this Congress, we continue to build support and anticipate that this momentum will be helpful in getting the provision included in broader WIOA reauthorization early next year.

We also continue to follow up on our meetings with stakeholders from the June Hill Day event to request cosponsorship of the bill.

Rep. Bonamici Meeting

This month, our team was able to schedule a Member-level meeting with Rep. Bonamici (D-OR), a leading voice for CTE and workforce development in Congress. This was a very productive conversation around the COTA Act, broader WIOA reauthorization, and her support of Perkins funding. We look forward to continuing to build the relationship with this office.

Other Updates

Looking ahead, our team is prepared to support AWFS's work on an updated strategic plan in whatever capacity is most helpful. We are also prepared to work with AWFS to develop a state-level strategy around manufacturing jobs in California, if and when the association is prepared to take on this initiative.

Workforce Innovation and Opportunity Act of 2022

Workforce Innovation and Opportunity Act of 2022 This bill reauthorizes through FY2028 and expands programs under the Workforce Innovation and Opportunity Act (WIOA). The bill also revises workforce investment, vocational rehabilitation, employment, training, and literacy programs for eligible individuals. For example, the bill * increases workforce representation on state and local workforce investment boards from 20% to 30%; * reworks one-stop center infrastructure funding by requiring costs to be covered by state allocations of WIOA funds; * establishes subsidized youth employment programs that include work-readiness training and mentoring; * eliminates a requirement that the Department of Labor ensure that individuals participating in WIOA activities comply with Selective Service laws; * modifies the allotment of youth workforce investment funds to states; * expands the Job Corps program, including by serving individuals in outlying areas and relaxing age requirements; * establishes grants to expand training programs through industry or sector partnerships; * expands grants for integrated English literacy and civics education to outlying areas; and * expands Wagner-Peyser employment services to the Northern Mariana Islands and American Samoa. The bill also provides statutory authority for Labor to award * competitive grants, contracts, and cooperative agreements to improve employment and training outcomes and reduce recidivism of justice-involved youth; and * competitive grants for states to create workforce longitudinal administrative databases.

Investing in American Workers Act

Description

Investing in American Workers Act This bill allows a businessrelated tax credit for employers who increase worker training expenditures. The credit is equal to 20% of the excess of (1) the qualified training expenditures for the year, over (2) the average of the adjusted qualified training expenditures for the three previous years. If the employer had no qualified training expenditures in any one of the three previous years, the credit is equal to 10% of the adjusted qualified training expenditures for the year. The credit applies to expenditures for the training of non-highly compensated employees (annual compensation does not exceed \$82,000). The training must result in the attainment of a recognized postsecondary credential and be provided through * an apprenticeship program; * a program of training services that is included on a list of eligible training providers that states are required to maintain under the Workforce Innovation and Opportunity Act; * a program that is conducted by an area career and technical education school, a community college, or a labor organization; or * a program that is sponsored and administered by an employer, industry trade association, industry or sector partnership, or labor organization. Certain small businesses and tax-exempt organizations may apply the credit against payroll taxes, subject to specified limits and requirements. Eligible small businesses may also apply the credit against the alternative minimum tax.

Employer-Directed Skills Act

Description

Employer-Directed Skills Act This bill allows for an employer to sponsor skills development programs with partial federal reimbursement under the Workforce Innovation and Opportunity Act (WIOA). These new skills development programs are exempt from the program application and participant assessment requirements that typically apply to WIOA employment and training activities. However, these skills development programs must be conducted according to an employer-sponsored skills development agreement that includes, among other required provisions, a commitment by the employer to employ an individual upon successful completion of the program. The bill also requires the federal share of these skills development programs and the federal share of existing on-the-job training programs to be paid by reimbursement from employer-directed skills accounts that must be established by local one-stop operators.

Build Back Better Act

Description

This bill provides funding, establishes programs, and otherwise modifies provisions relating to a broad array of areas, including education, labor, child care, health care, taxes, immigration, and the environment. (The bill is commonly referred to as the Build Back Better Act.) For example, the bill provides funding for * management of the National Forest System; * job placement and career services; * safe drinking water and energy-efficiency projects; * electric vehicles and zero-emission, heavy-duty vehicles; * public health infrastructure and supply chain resiliency; * housing, rental, and homeowner assistance programs; * cybersecurity programs; * tribal infrastructure, environmental, and health programs; * wildfire prevention, drought relief, conservation efforts, and climate change research; * small business assistance and development; * transit services and clean energy projects in low-income communities; and * infrastructure and administration of the Department of Veterans Affairs. The bill also includes provisions that * provide free child care for children under the age of six; * provide free universal preschool services; * establish a methane fee for certain petroleum and natural gas facilities; * expand Medicare to cover hearing care; * allow certain aliens who entered the United States prior to January 1, 2011, to temporarily remain and work in the country; * provide up to four weeks of paid family and medical leave per year; * restructure and increase taxes for certain corporations and high-income individuals (e.g., individuals with income over \$400,000); and * require the Department of Health and Human Services to negotiate maximum prices for certain brand-name drugs under Medicare.

Bringing Registered Apprenticeships to Veterans Education Act or the BRAVE Act This bill requires the Department of Labor, in the implementation of the Transition Assistance Program, to provide information concerning apprenticeship programs to members of the Armed Forces who are separating from active duty. The bill also requires Labor, in coordination with the Department of Veterans Affairs (VA), to establish a publicly accessible and user-friendly website on which veterans can find specified information about apprenticeship programs that are approved under VA education benefit provisions.

Title Trillion Trees Act

Description

Trillion Trees Act This bills establishes a variety of requirements and incentives to plant trees and conduct other land management practices for the purposes of capturing and storing carbon in domestic and international trees and forests. Additionally, the bill provides incentives to research or develop other carbon sequestration tools. Specifically, the bill directs the Department of Agriculture (USDA) to set targets to increase forest carbon stock through January 1, 2100, for the purposes of sequestering and storing carbon in U.S. forests. It also establishes and provides funding for the Trillion Trees Challenge Fund to provide grants to nonfederal entities for activities related to reforestation efforts on public or private lands. In addition, it raises the cap on the Reforestation Trust Fund to enhance forest health in the National Forest System and requires the USDA to establish a Tree City USA Grant Program. The bill also allows the U.S. Agency for International Development to enter into an agreement with a nonprofit organization to establish an International Forest Foundation to promote reforestation and prevent deforestation. Additionally, it establishes requirements and incentives to address seedling shortages and support nurseries. Finally, the bill provides market incentives to research or develop other carbon sequestration tools relating to biochar, sustainable building practices, biochemical and bioplastic products, and biomass energy.

Rural Jobs Act This bill allocates an additional \$500 million in 2022 and 2023 for new markets tax credit investments in the Rural Jobs Zone (an area comprised of low-income communities with populations not greater than 50,000 that are not adjacent to an urbanized area). The bill also requires that at least 25% of such investments be made in areas that are persistent poverty counties, high migration rural counties, or both.

National Signing Bonus Act of 2021

Description

National Signing Bonus Act of 2021 This bill replaces existing Federal Pandemic Unemployment Compensation payments for unemployed individuals with two-time signing bonuses for newly employed individuals. Specifically, the bill allows states to provide up to two direct payments to individuals who are eligible for Federal Pandemic Unemployment Compensation prior to commencing employment with a new employer. The individual must continue employment with the new employer for at least four weeks before July 4, 2021, to be eligible for the first \$1,212 payment under the bill and for at least eight weeks before July 4, 2021, to be eligible for the final \$1,212 payment. The bill otherwise eliminates federal reimbursement for Federal Pandemic Unemployment Compensation payments.

Helping to Encourage Real Opportunities (HERO) for Youth Act of 2021

Description

Helping to Encourage Real Opportunities (HERO) for Youth Act of 2021 This bill modifies the work opportunity tax credit to (1) change the credit for summer youth employees to a credit for youth employees who will be employed for not more than 20 hours per week during any period between September 16 and April 30 in which the youth employee is attending any secondary school, (2) increase the amount of the credit for youth employees, and (3) expand the credit to include disconnected youth. The bill defines disconnected youth to include any individual who (1) is certified as having attained age 16 but not age 25 on the hiring date; and (2) has self-certified as not having regularly attended any secondary, technical, or post-secondary school during the 6-month period preceding the hiring date, has not been regularly employed during such period, and is not readily employable due to a lack of basic skills. The term also includes individuals who have been certified (1) as having attained age 16 but not age 21 on the hiring date, and (2) as eligible foster children in foster care during the 12-month period ending on the hiring date.

It also reduces the amount of FPUC to \$150.00 for weeks of unemployment ending after May 31, 2021, and ending on or before June 30, 2021. Under current law, an individual is eligible for FPUC for weeks of employment ending on or before September 6, 2021 in the amount of \$300.

REO Act of 2021 This bill establishes the Reentry Employment Opportunities Program to make grants for the purpose of providing job training opportunities to formerly incarcerated adults, youths, and young adults who have dropped out of school. Grants are awarded to entities such as nonprofit organizations, organizations serving women or a minority population, and state and local governments to carry out projects related to apprenticeship programs, occupational skills education, on-the-job training, work experience, job referrals, basic skills remediation, educational services, and work readiness activities for such individuals.

Description

Back to Work Bonus Act This bill permits states to provide a onetime lump sum payment, through July 1, 2021, to individuals who (1) were eligible for COVID-19 pandemic unemployment compensation during any week after enactment of this bill, and (2) are no longer eligible as a result of becoming thereafter reemployed. Payments of \$1,200 shall be paid to individuals who work at least 30 hours and \$600 to individuals who work at least 20 hours but less than 30. The payments are available for claimants (1) who are not employed by a government entity, (2) who return to work for at least four consecutive weeks, and (3) whose annual salary does not exceed \$75,000. Before receipt of a payment, the individuals' employers must verify their hours and earnings. Additionally, the bill (1) accelerates a scheduled increase in funding for reemployment services and eligibility assessments (RESEA), (2) allows states to use RESEA funds to serve all workers receiving unemployment benefits, and not just those most likely to exhaust their benefits; and (3) allows states to provide reemployment services to individuals receiving pandemic unemployment assistance and pandemic emergency unemployment compensation. Finally, the bill reinstates the requirement that unemployment claimants certify they are able, available, and actively seeking work.

Title

504 Modernization and Small Manufacturer Enhancement Act of 2021

Description

504 Modernization and Small Manufacturer Enhancement Act of 2021 This bill modifies the Small Business Administration (SBA) 504 Loan Program, which provides a small business with SBA financing —through a certified development company (CDC) intermediary for expansion or modernization. Specifically, the bill adds policy goals, at least one of which a CDC must demonstrate to be eligible for assistance. These include (1) enhancing the ability of a small business to reduce costs by using energy efficient products and generating renewable energy, and (2) aiding the revitalization of any area for which a disaster has been declared or determined. The bill also authorizes a CDC to take specified actions to facilitate the closing of a 504 loan, such as correcting borrower or lender information on loan documents or reallocating up to 10% of the cost of a project. For small manufacturers, the bill (1) increases the maximum loan amount from \$5.5 million to \$6.5 million, (2) reduces the amount that they must contribute to project costs, (3) increases job retention requirements, and (4) revises collateral requirements and debt refinancing considerations. Further, each SBA district office must partner with a resource partner to provide certain training for small manufacturers.

Description

Pell to Grad Act This bill raises from 12 to 16 the total number of semesters during which a student may receive a Pell Grant. It also allows income-eligible graduate students who received Pell Grants during their undergraduate education to utilize their remaining Pell Grant eligibility toward their first graduate degree, subject to this 16-semester duration limit. Currently, Pell Grants are available only to undergraduate students, subject to the 12-semester duration limit.

Climate Stewardship Act of 2021

Description

Climate Stewardship Act of 2021 This bill provides funding and incentives for states, Indian tribes, local governments, and other entities to carry out climate stewardship practices, including farm and ranch conservation practices, reforestation projects, and wetland restoration projects. For example, the bill extends through FY2030 the Conservation Reserve Program, the Agricultural Conservation Easement Program, the Environmental Quality Incentives Program, and the Conservation Stewardship Program. It also modifies and increases funding levels for some of these programs. The Forest Service must award cost-share grants to states, Indian tribes, local governments, and nonprofit entities to conduct projects to reforest certain land. The bill also establishes a civilian conservation corps to provide youth from low-income communities, indigenous communities, and communities of color with the academic, vocational, and social skills necessary to pursue long-term, productive careers in the forest sector and the wetland restoration sector. Further, the bill sets forth a grant program for states, Indian tribes, local governments, institutions of higher education, and nonprofit entities to conduct coastal wetland restoration projects, including projects that mitigate greenhouse gas emissions.

Workforce Data for Analyzing and Tracking Automation Act of 2021 or the Workforce DATA Act This bill provides for a study by the National Academies of Science, Engineering, and Medicine on measuring the impact of automation on the workforce. Specifically, the bill requires the Department of Labor to request the academies to enter into an arrangement to conduct a consensus study on how to measure the impact of automation on the workforce, including job creation, job displacement, job retention, and the shifting of skills in demand due to automation. American Apprenticeship Act This bill directs the Department of Labor to make grants to assist states in carrying out projects that defray the cost of instruction associated with pre-apprenticeship and qualified apprenticeship programs. Success for Rural Students and Communities Act of 2021

Description

Success for Rural Students and Communities Act of 2021 This bill establishes a grant program through which the Department of Education may award funds to eligible partnerships to support rural postsecondary education and economic growth and development in rural communities. A grant recipient must be a partnership whose members represent at least three designated types of organizations, specifically (1) a local educational agency or educational service agency serving a rural area, (2) an institution of higher education (IHE), (3) a regional economic development entity, or (4) a rural community-serving organization with demonstrated success supporting rural students in accessing higher education and attaining degrees. Repairing Existing Public Land by Adding Necessary Trees Act or the REPLANT Act This bill directs the Department of Agriculture (USDA) annually for each of the 10 years after enactment of this bill to transmit to Congress an estimate of the sums necessary to be appropriated, in addition to the funds available from other sources, to replant and otherwise treat an acreage equal to the acreage to be cut over that year, plus a sufficient portion of the backlog of lands found to be in need of treatment to eliminate the backlog within the 10-year period. The bill provides statutory authority for the Office of Apprenticeship (OA) within Labor. The bill provides statutory authority for criteria for various programs, including (1) quality standards for apprenticeships, (2) requirements for apprenticeship agreements between a program sponsor and an apprentice, and (3) acceptable uses for grant funds awarded by this bill. The bill also provides statutory authority for the National Advisory Committee on Apprenticeships. The committee's duties shall include advising the OA on matters relating to this bill and providing recommendations on topics such as increasing the participation of populations not traditionally involved in the national apprenticeship system. Raise the Wage Act of 2021 This bill increases the federal minimum wage for regular employees over a 5-year period, for tipped employees, and for newly hired employees who are less than 20 years old. Labor must publish any increase in the minimum wage in the Federal Register and on its website 60 days before it takes effect.
